Wyatt Asbury died in 1858, his inventory being Feb. 2, 1858 and his administrator being William P. Asbury (W. B. 3, pp. 263, 284, 393, 496); and his wife, Elizabeth Asbury, died in 1859, her inventory being Mar. 3, 1859, and S. W. Higgenbotham her administrator (W. B. 3, p. 282 and 514). Deeds in 1859 and 1860 (D.B. 12, p. 526; D.B. 13, pp. 338, 481) show that Wyatt Asbury had 7 children as follows; the first 5 of them being mentioned in the deeds, the last two being probable rather than proved children:

John⁵ Asbury, son of George⁴ and Mary Ann Asbury, was born 1793-4 (aged 56 Census of 1850) and died in Tazewell Co. between Feb. 27, 1858, when he deeded land to his son George (D.B. 12, p. 323), and Oct. 2, 1858, when his children deeded away his land (D.B. 13, p. 49). He married quite young on Jan. 17, 1811 Polly Ratliff, who died prior to 1850. The Census of 1850 and two deeds by which his heirs disposed of his land (D.B. 13, p. 49 and 226) show that John and Polly (Ratliff) Asbury had 12 children as follows:

- Shadrack Asbury, b. 1827-8, unmarried 1850. VI.
- VII. Wyatt Asbury, b. 1829-30, living with brother George Asbury in 1850, married Emaline _____ after 1850.
- Charlotte Asbury b. 1832-3, unmarried 1850, m. William Hooper. VIII.

Henry⁴ Asbury was apparently younger brother of William⁴ and George⁴ Asbury, and a son of John' Asbury. He was born about 1760-64 and married in Washington Co.,
