

Anne (or Anne) Graves (5) was born about 1620, and died 2 March 1683/4 in Charles County, Maryland. Her will was proved 18 July 1683 in Charles County, Maryland. She first married Rev. William Cotton, son of Andrew Cotton and Joane -----, before 10 July 1637 in Hungar's Parish, Accawmack (or Accomac) County, Virginia. He died in 1640. There is a tradition in the family that he was a son of widow Joan Cotton of Bunbury, Cheshire County, England, and was granted 350 acres of land on the main branches of Hungar's Creek, adjoining the lands of his brother-in-law, Capt. William Stone. This consisted of 100 acres for personal adventure of himself and wife and 250 acres for the transportation of five persons to Virginia, viz. Eleanor Hill, Richard Hill, Edward Eason, and Domingo and Sambo, negroes. William Cotton was succeeded by Rev. John Rozier.

Anne secondly married Nathaniel Eaton, son of Richard Eaton, about 1641 (by 1642). Nathaniel was assistant to Rev. Rozier, and was previously the first head of Harvard College. He went to Virginia after his dismissal from Harvard. He fled from his creditors in Virginia about 1647, deserting his family, and died in 1674.

Anne thirdly married Francis Doughty, son of Francis Doughtie, on 8 June 1657. He died about 1683. He, like Ann's first two husbands, was Rector of Hungar's Parish. She later went with him to Old Rappahannock County, where he was Rector of Sittenbourne and South Farnham Parishes in 1665. (R-114, R-51]

most eccentric and picturesque figures in early colonial times. Francis Doughty was the son of a brewer in Bristol, England, and the brother-in-law of Governor Stone of Maryland. He was educated for the church, but cast in his lot with the Puritans, and emigrated to America. We find him located at Cohasset, now Taunton, Mass. Here he got into a dispute with the elders on the subject of infant baptism, and pressed his views so vehemently that he and his wife and children were banished. He fled to Rhode Island, and from thence joined one of the first English Colonies that settled among the Dutch on Long Island. He became the Pastor of the little community that settled at Mezpah-Kill, afterwards Newtown. This settlement was broken

up by the Indians in 1643; the remnant of the colony, with Mr. Doughty, fled to New Amsterdam, where he preached in the church in the Fort. He made a claim for the colonists' land at Mezpah-Kill as his own, which was disputed and decided against him in 1647, but he was allowed the land he had in posession. Appealing from this decision, the Dutch Director, General Kieft, fined him ten guelders and locked him up in prison for twenty-four hours. Upon his release, Mr. Doughty applied for permission to go to Holland or the West Indies, but this was refused. He had accepted a call from the Congregational Church at Flushing, L. I., where he preached during 1646 and 1647. Here he again got into trouble by denouncing the authorities, so that Capt. John Underhill, who was then living in that town, locked the doors of the church against him. Mr. Doughty, leaving his three children behind him, in 1648 emigrated to Maryland. There he appears to have changed his religion and returned to the English Church, and became Rector of Sittingbourne Parish in Virginia. While officiating here, he baptized, in 1659, the eldest son of John Washington, grandfather of George Washington. Here also he got into difficulties for denying the supremacy of the King, contrary to the canons of the church.

Rev. Francis Doughty had three children: Mary, Francis, Jr., and Elias. Elias was the grandfather of Daniel Doughty.

States rather than to the Congregationalists of Massachusetts; and that they freely described their position as Presbyterian. (Page 14, 15) The migration from New England to Long Island was largely Congregational; and yet two of the Ministers who were among the early emigrants were Presbyterians -- Francis Doughty, in 1642, and Richard Denton, in 1643. (Same ref., Page 25. See also Chap. 16, below)

Rev. Charles A. Briggs, D. D., in "American Presbyterianism," Page 93-108, states that the Presbyterian Colony at Salem and the congregational Colony at Plymouth were in accord. The Presbyterian Ministers of New England made a happy accommodation with the Congregational Ministers, as their brethren in England subsequently did. According to the Cambridge Platform, as well as the westminster Directory, the Congregational Presbytery should have existed in every local Church; but it was afterward found to be impracticable. So that, gradually, the Congregational Presbytery passed out of use in New England. Dr. Briggs then mentions Rev. John Youngs, of Southold, as the first Puritan Minister in New York; Rev. Abraham Pierson, of Southampton, as the second; Rev. Francis Doughty, of Newtown, as the third; Rev. Joseph Fordham, of Hempstead and Southampton, as the fourth; and Rev. Richard Denton, of Hempstead, as the fifth. In all, he states that there were eight Puritan Ministers in the Province of New York, in 1678. Doughty was the first Presbyterian Minister in New York City; and Denton was the second.

Francis Doughty, of Taunton, Mass., in 1639, removed to Long, Island in 1641, lived in Rhode Island awhile. "In 1649, Franciscus Douthy, an English clergyman here, came to N. E., at the time of the persecution in England. He betook himself under the protection of the Netherlands, in order that he may, according to Dutch Reformation, enjoy freedom of conscience, which he unexpectedly missed in New England.

In 1642. The Director granted and conveyed to him an absolute patent with manoral privileges. He added some families to his settlement, at Maspeth, L. I., in the course of a year, but the war breaking out, they were all driven off their lands, some were killed -- and almost all they had was lost. They fled as all refugees did, to Manhattan, and Master Douthy was minister there. He was without means and his land was seized by the Director; Douthy appealed but the Director said there was no appeal, his decision must be final, and for his remarks, Doughty was sentenced to imprisonment 24 hours, and to pay 25 Guilders. The deed was for 6,666 acres of land, at Maspeth, from Gov. Keift. Col. Rec.

Rev. Thomas Lambert Moore was own uncle to Rev. David Moore, D. D., of Richmond, Staten Island, brother-in-law to Elbert Floyd-Jones, and still more remarkable, at the death of the Rev. John Moore, his widow Margaret Howell Moore, married Francis Doughty, Junior, son of the Rev. Not finding in Plymouth Colony the religious freedom which he sought, and the Narragansett country being as yet too lonely and dangerous a residence for his family, Richard Smith came to New Amsterdam, where he was gladly welcomed by the Dutch. With him came from Taunton others, who too sought freedom of conscience; among them was John Smith, probably a brother of Richard,--and Rev. Francis Doughty, a dissenting clergyman who, while preaching at Cohasset, Mass., had been dragged out of the assembly for venturing to assert that "Abraham's children should have been baptised." Director Kieft immediately (1642) granted to them an absolute title to more than 13,000 acres of land at Mespath, now Newtown, Long Island. The Patent was made to "Francis Doughty and companions," and gave them full power to build villages and churches, to exercise their own form of Christian religion and church discipline, and to administer their own laws, subject only to their acknowledging, during their possession of the land, the sovereignty of the Dutch West India Company. Doughty had no means of his own and had merely acted as agent for Richard

The will of William Stone was dated December 3, 1659, and proved on December 21, 1660, in Charles County, by Francis Doughty, Stephen Montague, and Stephen Clifton. He named as overseers of his estate and the guardians of his minor children Governor Josias Fendall, his brother-in-law Francis Doughty, and his "natural" brother Matthew Stone.

(\*)Note: It is sometimes said that Anne, born 1622, who married Nathaniel Eaton and in 1657 married Francis Doughty, of Accomac County, and who in 1662 during a law suit named Elizabeth (Stone) Calvert as her cousin, was a sister to Governor Stone. The word "cousin" signified merely kinswoman, for it is proved that the Rev. Nathaniel Eaton by 1642 had married Anne, the widow of the Rev. William Cotton. She was therefore born Anne Graves whom William Cotton transported into Virginia and whom he acknowledged

as his wife in 1637.

Anne Graves, daughter of Capt. Thomas Graves, born 1620, married successively three ministers of Hungars Parish, Accawmack. She married (1), before 10 Jul 1637, the Rev. William Cotton, who on that date patented land in right of his wife Anne Graves (22 above). He left will, Aug 1640-29 Dec 1646, naming "Brethrin-in-Lawe Capt. William Stone and Capt. William Roper as overseers". She married (2), by 1642, the Rev. Nathaniel Eaton. She married (3), as his (2) wife, the Rev. Francis Doughty. She died in Charles County, Maryland, will, 26 Dec 1682-18 Jul 1683 (24 above and APP327-30).
