

**MORRIS and HAYNIE of NORTHUMBERLAND, VIRGINIA**  
**and**  
**HARRIS of SOUTH CAROLINA**

Nicholas Morris, whose daughter, Jane, married John Haynie, patented 182 acres in Northumberland County, Nov. 1652, "upon a creek dividing this from the land of said Morris" which indicates that he had previously purchased land in that county. (C.P. 266) His next patent was for 512 acres June 1, 1654, upon Great Wicomico River for the transportation of 11 persons. (Id. 314) It is very probable that Nicholas Morris came to the county from Maryland. He was born in 1605 and his wife, Martha, in 1609. (Depositions) He was a Justice of the County Court from 1652 until his death in 1663. Either he or his wife seem to have been related to Col. John Mottram, for in 1658, George Colclough, who married Ursula, the widow of Colonel Mottram, deeded a mare to Nicholas Morris for the "sole use of Jane Haynie, daughter of said Morris and wife of John Haynie". Nicholas Morris' will was dated Nov. 21, 1660, and proven Jan. 20, 1664. He gave his son, Anthony, 550 acres of land and his wife, Martha, 506 acres. He also mentioned his daughter, Jane Haynie, and her children, Martha, Elizabeth and RICHARD HAYNIE. Martha, widow of Nicholas Morris, married Thomas Lane, a large landowner of Northumberland.

Anthony Morris, the above son, died in 1682 without children. His widow, Dorothy, had married Cuthbert Spann by Jan. 3, 1693, for the Court ordered that Anthony's estate be divided between Dorothy, the relict, and Jane Haynie, the heir of said Morris. (25V 193)

Jane Morris, daughter of Nicholas, married John Haynie of Northumberland. John Haynie, ancestor of this distinguished and widely spread Southern family, patented land in Northumberland Co., 350 acres, on March 10, 1662, at the head of Wicomico River upon land of Colonel John Mottram, decd., etc., for the transportation of 7 persons (C.P. 462) One of his neighbors was John Hughlett who patented 900 acres June 3, 1663 "Bounding N. by E. upon 1200 acres patented by Col. John Mottram, decd. and easterly upon land of John Haynie." (Id. 463) Hughlett's place was called "Hughlett's Tavern", later it was known as "Heath Store" and when it became the county seat was called "Heathville".

John Haynie was a Justice of the County Court, Burgess from the county 1657-58 and a Captain in the Susquehanna Indian War. (B.J., Stanard's Reg.)

Inventory of Capt. John Haynie's estate was filed in 1713 (Torrence) Aug. 22, 1723, personal estate of a John Haynie was valued at 10416 lbs. Tbc. (Bk. 19-395) Inasmuch as Capt. Haynie died intestate there is no exact proof of his children unless it is shown in wills of relatives, deeds, or court orders. William Haynie was appointed administrator of a John Haynie's estate April 25, 1723. He may have been William's brother. (Bk. 7-164)

Capt. John Haynie is said to have had six children: RICHARD (see later); JOHN and ANTHONY, ELIZABETH, MARTHA and ANN. Only Richard, Martha and Elizabeth are mentioned in the will of their grandfather, Nicholas Morris, dated in 1660. Maybe the others were born after that time or were the children of a second wife.

Richard Haynie, son of Capt. John, was born about 1660 and died in 1724. He married, first, Oct. 10, 1681, Elizabeth Bridgar, born July 16, 1665, died April 4, 1697.

Richard Haynie was a Burgess from Northumberland in 1695-98 and 1702-05. He was evidently a non-conformist for at a term of Court in 1715, Capt. Richard Haynie was ordered to be taken into custody and to give bond for not going to church and he and his second wife, Elenor, were fined. (O.B. 6-137) Capt. Haynie made his will Oct. 31, 1724, proven March 18, 1724-5. (D.B. 1718-26, p. 389) He bequeathed to son BRIDGAR, "land on road near the Court House and plantation where I live. If he die without heirs to go to sons MAXMILLAN and ORMSBY HAYNIE; to son ORMSBY and CHARLES other lands; son SAMUEL HAYNIE, 80 acres adj. Richard Oldham, rest of estate to be equally divided between daus. KATHRINE, ELINOR, WINIFRED and ANNA, dau. ELIZ SMIT a gold ring. extrs. wife, Elinor and Major George Eskridge."

The will of Elinor Haynie, relict of Capt. Richard Haynie, was presented for probate by Samuel Haynie, an executor, Sept. 10, 1754.

The tomb of Elizabeth Bridgar Haynie was found in a farm graveyard in 1914 near Heathville and the dates of her marriage and birth and death were shown thereon. "She had eight children". (22W (1) - 88)

He married secondly, Elinor, by whom he had six children.

Children of first wife from wills and Parish Reg: Bridgar (father's will); John (bro. Bridgar's will); Elizabeth, b. Dec. 6, 1686; Maxmillian, b. Oct. 31, 1688; Ormsby (in father's will); Anne, (in father's will); Katherine, (in father's will); Samuel (in father's will).

Children of second wife, Elinor: Mary, b. Nov. 3, 1702; William, b. Nov. 5, 1704; Winifred, b. April 7, 1706; Elinor, b. Sept. 2, 1708; Charles, b. Jan. 23, 1710; Sarah, b. May 11, 1718.

Maximillan Haynie, son of Elizabeth and Capt. Richard Haynie, was born Oct. 31, 1688 and died, with a will, in 1729. His will was dated Feb. 6, 1727/28 and probated May 20, 1729, in Northumberland. (R.B. 1726-29-C-1324) His legatees were: son, URIAH; dau. ELIZABETH HAYNIE, b. July 20, 1725; son MAX-

IMILIAN; estate to be divided between wife, MARY and children.

Maximillian Haynie Jr. was born in Northumberland Co.; Oct. 21, 1723. (St. Stephens Reg.) and died about 1780 in the Pendleton District, S. C. His wife was a Miss Falkner whom he married about 1743. The only Haynies in the South Carolina Census of 1790 were a John Haynie in Pendleton, head of a family consisting of himself, 2 sons under 16, a wife and a daughter, also 3 blacks. Stephen Haynie in Pendleton had himself, a wife and daughter. Maxmillian is said to have moved from Prince William County to Newberry, S. C. about 1772.

Maximillian Haynie's only known children as of today were a daughter, Jean (see later) and another daughter, Mary.

Jean Haynie married Burr Harris of Northumberland Co., Va., later of Newberry, S. C., about 1757. Burr Harris was a corporal for 3 years in the Virginia Continental Line. (Gawthmey-352) Also he furnished a horse for the Continental Army. (Pr. Wm. Booklet-192) Burr was born about 1728 and died in Newberry, S. C., March 8, 1787. His wife, Jean, died in 1786. Their children were: George m. Martha (See later); Obed; Micajah; Thomas; Jean; Lettie; and Chloe Harris.

Mrs. Lois Scheck Pitts, a descendant of Burr's son, Micajah, says that Burr (Calvert) Harris came from Virginia in 1772 and bought part of an original grant to Jeremiah Williams. He acquired the other part of the grant in 1773. Her house, now 180 years old, was used as a hospital during the Revolution and is now occupied by Mrs. Pitts. In the family cemetery behind the house are buried Burr Harris; Lt. Micajah Harris of the Rev., Micajah Harris II; Lt. A. T. H. Scheck, died of wounds at Winchester, Va., in 1862.

George Harris, son of Burr and Jean (Haynie) Harris, was born about 1758 in Northumberland Co., Va.; died Aug. 23, 1819, at Edgefield, S. C.; married about 1777, Newberry Co., S. C., Martha ----- . Their children were: Micajah (Cage) Harris, Craven, Thomas Joshua, William m. Martha ----- . (See later), George Jr., Jane, and Elizabeth Harris.

William Harris was born about 1778 at Newberry, S. C.; died Jan. 5, 1820, at Edgefield, S. C.; married about 1791 at Edgefield, S. C., Martha (Sanders?). He left nine children but all were not named in the will. Among his children were: George Washington Harris, b. 1809, m. Elizabeth Cartledge (See later); Martha; Ann; Ellen; a daughter who m. Robert Crosson; and a daughter who m. James Walker.

George Washington Harris was born 1809 at Edgefield, S. C., died 1888 at Dadeville, Tallapoosa Co., Ala.; married 1830 at Edgefield, S. C., Elizabeth Cartledge, born 1809, Edgefield, S. C.; died 1883, Dadeville, Ala., daughter of Samuel Cartledge Jr. and his wife, Mary (Bird)? . Rev. Samuel Cartledge Sr. was a Baptist Preacher in S. C. and Georgia. The children of George Washington and Elizabeth (Cartledge) Harris were: William Harris m. Cathrene Thigpen; James Harris m. Mahuldia Mitcheal; Amanda Harris m. Joseph Taylor; Rev. Ransom Harris m. Jane Bryant; Mary Ellarenda Harris, b. July 4, 1843, m. John Wesley Madden (See later); Marshall Harris; and John Harris.
