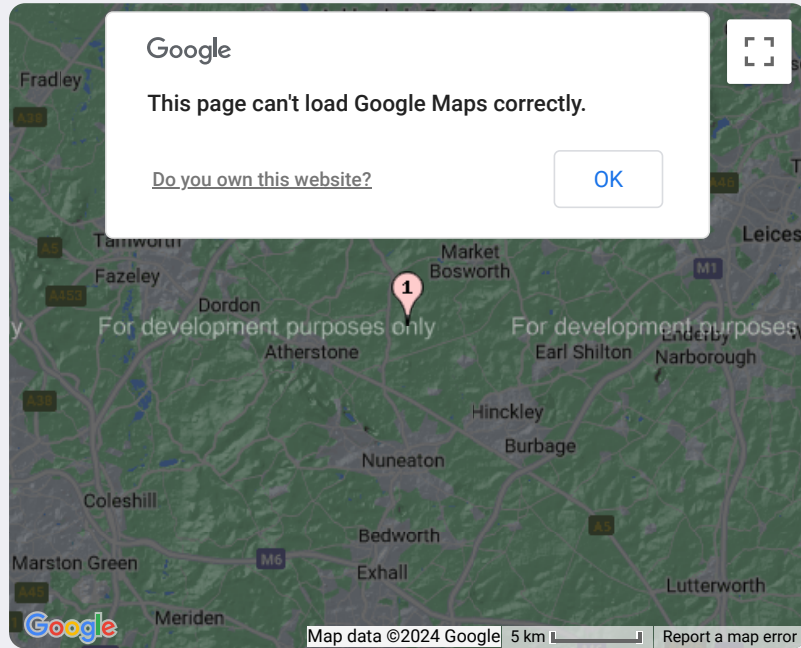

Know you yt: I MARTHA MORRIS of ye County supra written, ye Widdow & Relict of NICH:MORRIS, lately deced., for diverse good causes & consideracons but more especially for ye good will & Motherly affection which I have to my Son, ANT: MORRIS, have freely & clearly given & doe by these p:sents freely & absolutely give & bestow upon my sd: Son the goods chattels & moveables as fol: to say: seaven head of Neste Cattle, vizt. one Cow called Brindle & her Calfe, as alsoe Ten yews, one Ram, & a weather, wth: one halfe of all my hogs according to quantity & quality, 3 pewter dishes, 1 1/2 doz: porringers, one pewter cup & pot, a feather bed bolster pillow, 3 ruggs, one iron pott & pot hookes, 2 guns & a pistol!, as likewise at his ye sd; ANTONYs day of Marriage, or my decease (wch: he will of those times) one bed cowering wth: Qu: Eliza: Armes, thereon, one Turkey Carpett, one great brasse kettle & one small table & forme now in my possession; & then to be to him deliverd: likewise two red steares 2 yeares old & upwards, one steare a yeare old & above, one red heyfer & a cow calfe, all wth: (as before esprest) I doe give to my Son his heyres & assignes for ever; In Witness whereof I have hereunto sett my hand & seale ye 15th July 1665

THOMAS LANE doe bind mysele to warrant ye same to ye aforesd DAVID WHITFORD or his heires in as full manner as ever I enjoyed ye same as likewise I doe bind my selfe in twenty thousand pounds of tobaccoe in caske yt: ye sd. - MARTHA LANE against the Estate of her Husband Whereas a Bond under the hand and seale of THOMAS LANE for ten thousand pounds of tobacco was proved in this Court wherein THOMAS LANE did oblige himselfe to provide for his Wife, MARTHA LANE, on penalty of paying the same and whereas the Feoffee for MARTHA LANE did obtaine an Attachment against the Estate of THOMAS LANE for the same, THOMAS LANE being departed out of the Country without complying with the condition of the Bond, which Attachment was returned executed on the Estate of THOMAS LANE in the hands of ANTHONY MORRICE and Mr. WILLIAM THOMAS, Judgment is granted MARTHA LANE against ANTHONY MORRICE for the Estate of THOMAS LANE attached as aforesaid, itt not exceeding the same of ten thousand pounds of tobacco which same JOHN PAINE did make Oath in Court was the penalty of the Bond, and for what shall appeare due to MARTHA LANE in the hands of WILLIAM THOMAS attached as aforesaid ordered the whole doth not exceed the same of ten thousand pounds with costs als Execution

- LANE against THOMAS Whereas itt appeares to this Court that there is due to THOMAS LANE from WILLIAM THOMAS fourteene hundred twenty two pounds of tobacco and caske in part for a Bill of three thousand one hundred seventy two pounds of tobacco and whereas the tobacco is attached in the hands of WILLIAM THOMAS by MARTHA, the Wife of THOMAS LANE, Judgment is granted MARTHA LANE against WILLIAM THOMAS for the same

Northumberland County Court 18th of August 1675

The Honorable Justices of Northumberland County [this part in the black part at the top of the page which I cannot read except [humble Petition of JOHN HAYNIE] sheweth HAYNIE's Comm of Admon upon LANE's Estate that whereas THOMAS LANE some time ago hath dyed in Delaware Bay [or poynts adjacent] and his Wife surviving him the Thirds of his Estate became her legall right and she departing this life about ye 12th of April last ye right of her Estate (ye aforesaid Thirds] personall revolved unto her Children of which your Petitioner's Wife is one and whereas your Petitioner hath a present opportunity to send to ye Delaware Bay in quest of this Estate there where his Widdowes Dower must be had [or noe where] your Petitioner therefore humbly prayes Order of Administration on ye Estate of THOMAS LANE and he shall pray &c.

August ye 23d 1675. This Petition is granted giving security according to Law ST. LEGER CODD, WILLIAM PRESLY
