John Bulls family He md 1. place unknowndate but thought to bearound 1782a Miss Fletcher HOWEVER THIS IS NOT PROVED CHILD 1. William Spencer b c 1783 in North Carolina md c 1803 to whom and where unknown. died December of 1808 intestate in Smith co Tenn. evidently just passing through his belongings consisted of a horse, saddle and coat and was filed by his executor SHADRACK PHILLIPS it is thought that Shadrack was the brother or other close kin of John Bulls daughter Susannah 's husband Abner Phillips. I believe that William spencer had 2 boys by his marriage - where or when they were raised is unknown however a. William Spencer 1804-1846 b N.C. died 1846 IN WESTON, PLATTE CO MO. ACCORDING TO A COUNTY HISTORY REPORT ABOUT JAMES SPENCER AND NAMING HIM AS AS A NEPHEW This Wm Spencer had md 12 December 1833 Surry co N.C. to Susannah Dean d of Anthona Dean and Susannah-----Anthona Dean was killed in the war of 1812

b. William Spencers other son James Spencer was born 1805 and died ? he md Rebecca Dean d of Anthona and susannah.

BOTH SONS HAD CHILDREN AND I WON'T GO INTO THAT NOW - I HAVE CORRESPONDED WITH DESCENDENT WHO LIVES IN CARROLL CO VA.

2. James Spencer (ours) b by 1783 in North Carolina .Md 19 Nov. 1807 surry co n.c. with Benjamin H Martin bond to Sarah Lewis Martin b 1786 Surry co N. c. daughter of Obadiah Martin son of David Martin and Mary and brother of Salatheil Martin all three in Revolutionery War James died 6 January 1819 in Bloomington twp buchanan Co. Mo and is buried on the home place there he died intestate and the estate was handled by Cornelius Burgess (a son in law)James O'Toole and Silas McDonald. Sarah was alive in 1862 but I do not know her date of death. She is also buried on the home place I WILL ADDRESS THEIR FAMILY LATER

3. Susannah Spencer b c 1784in North Carolina (ref the 1860 census) md 2 February 1809 in Surry co N. C. to Phillip Phillips son of Abner Phillips Phillip Phillips died October 1828 in Surry co N.C. w.b.4 pp15 she and Abner Woodruff were executors of his will. SO SHE WAS A WIDOW BEFORE JOHN BULL DIED I WILL ADDRESS THEIR FAMILY LATER Susannah was alive in 1860 on the Surry co Census in the home of her youngest daughter pp 386

4. Joseph Spencer b c 1786 in North Carolina. md 15 June 1810 in Charlotte co North Carolina to Annie Rowton d of Wm Wroton of Charlotte co Va. His uncle Charles spencer was surety (youngest brother of John Bull Spencer) It is thought that Joseph was back in Charlotte co as John bulls mother died c 1810 there (other family members did things about that date) and he was there on his fathers business. There were Rowtons in Surry co N.C as well so he was probably familiar with the family. She was the daughter of William Rowton 1782 5-5 or Wm Rowton Jr. 1782 3-1. They returned to Surry co and she had a son Richard Spencer b c 1812 Joseph bought land from his father in Surry (see deeds) I believe something made them move. Joseph sold out at a profit and went to Rutherford co Tenn. Annie probably died there having a second child. Joseph died in Tenn. before 5 April '8 1837 for sure and maybe as early as 1825. Richard the son applied for his share of John Bulls estate from tennessee.

5. Sarah Spencer b c 1788in North Carolina she md 19 August 1811 in Surry co N.c. to James Greenwood bond bv Robert E Adkins who was md to james sister Katie Greenwood. The Greenwood family Samuel Greenwood and his wife Sybil Street were from Middlesex co Va. and had recently moved to Surry co N.C. James Greentwood died in 1839 in surry co and his will was proved February 1840 in Surry co N.C. with his son John Greenwood administrator. Sarah was alive onthe 1850 Surry co N.C. census living with her daughter Susan Elizabeth who had md Gideon Jefferson McMickle I do not know when she died Sarah also known as Sally Spencer Greenwood.

6. Nancy Spencer b c 1792 (she lies about her age on subsequent census so who knows?) In North Carolina she md 1. 11 April 1812 in Surry co N.C. to George Thomason who was dead by May of 1817 when she md for the 2nd time 13 May 1817 to William Spencer Jr. (probably a first cousin) by 1830 they were in Meade co Ky and applied from there for their share of John Bulls estate. I WILL ADDRESS HER FAMILY LATER

7. JOHN SPENCER JR. B on some census 1794-1800 and on a later census taken by 1800. not sure of exact date. he md 22 August 1827 in Surry co N.c. to Martha "Patsy" Gray b 1800 N.C. the bond on the marriage was signed by James Spencer (oura) He died by 1840 when his estate was administered in Surry co N.C. He left a family of 9 children and Patsy was alive on the 1870 census of Wilkes co N.C. in Edwards twp I do not know where or when John died or where he is buried. I WILL ADDRESS HIS FAMILY LATER

We know John Bull Spencer was md twice first to a Miss Fletcher possibly Nancy daughter of Wm Fletcher who was in Wilkes co later THIS IS NOT AS YET PROVED

We do know that John Bull Spencers wofe died and he made a trip to Madison co West Tenn where he took out land (this from later records) when he came back to Surry co N. C he md for a second time 14 December 1821 in surry co N.D. to Sarah Andrews with his son James Spencer (ours) signing the bond. After John Bull died in Lawrence co Ky she md again in 1831 in Lawrence co Ky to Henry Burgess and I believe they went to Jackson county Mo. with the migration.

I hope I gave you some new information you can download this I managed to download yours and actually was able to find it later PROGRESS
