- The action of trespass upon the case between James Porteus, plaintiff and William Spicer, defendant is dismissed.

1739-1741 Orange County, Virginia Order Book 2; [Mike Marshall]; Page 454 At a court continued and held for Orange County on Friday the 24th day of July 1741

- In the suit by petition brought by Joseph Morton, Gent, plaintiff and William Spicer, defendant, the sheriff having returned not executed for want of time. At the plaintiff's motion its ordered that a new summons issued against the said defendant returnable to the next court.

1739-1741 Orange County, Virginia Order Book 2; [Mike Marshall]; Page 477 At a court continued and held for Orange County on Friday the 28th day of August 1741.

- In the suit by petition brought by Joseph Morton, Gent, plaintiff against William Spicer, defendant for 4 pounds 3 shillings and 10 pence, the defendant appeared in confessed judgment to ye plaintiff for ye said sum. Wherefore its [Page 478] considered by the court that the plaintiff recover against ye said defendant the sum of 4 pounds 3 shillings and 10 pence and costs.

1741-1743 Orange County, Virginia Order Book 3; [Mike Marshall]; Page 32 At a court continued and held for Orange County on Saturday the 26th day of September 1741.

- The suit by petition brought by Patrick Dowdall, plaintiff against William Spicer, defendant is dismissed being agreed, the defendant paying all costs.

1741-1743 Orange County, Virginia Order Book 3; [Mike Marshall]; Page 32 At a court continued and held for Orange County on Saturday the 26th day of September 1741..

- Edward Newgent an evidence from Spotsylvania County for Patrick Dowdall against William Spicer having made oath that he had attended five days. Its on his motion ordered that the said Dowdall pay him 125 pounds of tobacco for the same according to law and 222 pounds of tobacco for twice coming and going 37 miles

1741-1743 Orange County, Virginia Order Book 3; [Mike Marshall]; Page 33 At a court continued and held for Orange County on Saturday the 26th day of September 1741.

- James Boyd an evidence for Patrick Dowdall against William Spicer from Spotsylvania County having made oath that he had attended five days, at his motion its ordered that he pay him for ye same 125 pounds of tobacco for his attendance according to law and 222 pounds of tobacco for twice coming and

going 37 miles.

1741-1743 Orange County, Virginia Order Book 3; [Mike Marshall]; Page 143 At a court continued and held for Orange County on Saturday the 27th day of March 1742.

- In the suit by petition brought by Richard Brandford, plaintiff against William Spicer, defendant for 1 pound 8 shillings and 11 pence half penny due by bill ye defendant not appearing. Judgment is granted the plaintiff against ye said defendant for 1 pound 8 shillings and 11 pence half penny current money and costs together with 7 shillings and 6 pence for and attorney's fee.

1741-1743 Orange County, Virginia Order Book 3; [Mike Marshall]; Page 213 At a court continued and held for Orange County on Saturday the 27th day of March 1742

- In the suit by petition brought by Alexander Cummins, plaintiff against William Spicer, defendant proved his account. Judgment is granted him against ye said defendant for ye said sum of 5 pounds current money and costs.

1741-1743 Orange County, Virginia Order Book 3; [Mike Marshall]; Page 230 At a court continued and held for Orange County on Saturday the 28th day of August 1742.

-In the action of trespass upon the case between James Hubbard, merchant, plaintiff and William Spicer, defendant, the defendant not appearing and the sheriff having returned that he kept him off with a club. At ye plaintiff's motion its ordered that an alias capias issued against ye said defendant returnable to the next court.

1743-1759 Orange County, Virginia Deed Book 10; [Antient Press]; Page 320 Know all men by these presents that I, WILLIAM SPICER, of Orange County, Parish of St. Mark's .. make over unto EDWARD WARE of same .. one bay Gelding with small star on his forehead .. feather bed, furniture .. and about 1000 pounds of tobacco .. for sum of £6.09.11 and 146 lbs. of Tobacco which William Spicer is indebted to Edward Ware 5 Nov 1745.
