#### THE HAYNIE LINEAGE

This line dates from time of Nicholas Morris on the paternal side, the father of Jane Morris who was the wife of Captain John Haynie, down thro Sallie Ball Haynie. (Captain John Haynie is the first of the line of which we have any record: he was born in 1624) and on the maternal side from the time of Mary Montague Johnson Ball, the grandmother of General George Washington down thro Sallie Ball Haynie. This proves us to be a direct descendant of Captain Richard Haynie, a Burgess of the house of Burgess of Virginia.

Col. Joseph Ball of "Epping Forest" Lancaster Co., Va., born in England May 24th, 1649, came to Virginia in his infancy. He died in June 1711. He married Mary Montague Johnson in 1707 who was born in England but at the time of her marriage to Col. Joseph Ball was a widow of Lancaster county Virginia. Mary Montague Johnson Ball was of Montague lineage. She was a descendant of Drog de Montacuto, born 1040 and he accompanied William the Conqueror to the shores of Britain and founded the Montague family of England and later Virginia. (Hayden's Genalogies, Pages 57 and 58.)

## THE HAYNIE LINE

Col. Joseph Ball married Mrs. Mary Johnson, a widow with two children, John and Elizabeth Johnson, about 1707. The only child of this marriage was Mary Ball, born in 1707 or 1708, who afterwards became the mother of George Washington.

The will of Col. Joseph Ball, dated June 25, 1711, mentions Elizabeth Johnson "daughter of my beloved wife". (Hayden's Va. Genealogies). The widow of Col. Ball -- Mary Johnson-Ball married Capt. Richard Hewes of Cherry Point Neck, St. Stephen's parish, Northumberland Co., Va. Capt. Hewes was a man of much local prominence and related to some of the most influential families of the country. He was Captain of Militia and for some years, with John Haynie, was warden of the St. Stephen's parish church.

The will of Cap't Richard Hewes was presented for probate on Feb. 14, 1714, by Mrs. Mary Hewes, his relict and executrix. The record book containing this will is missing but the Order book 1713-19 records the fact of its probate and proof. (Northumberland Co. records).

The will of Mrs. Mary Johnson-Ball-Hewes was dated Dec. 17, 1720; proved July 19, 1721 and she designates herself as "I, Mary Hewes of St. Stephen's Parish, North-umberland Co., widow".

In her will, Mrs. Hewes provides first for her young daughter, Mary Ball. She makes bequests to her son, John Johnson and twice mentions her daughter Elizabeth Bonum finally devising all the rest of her real and personal estate "unto my son John Johnson, and to his heirs lawfully begotten of his body, and for default of such issue, I give and devise the said estate unto my daughter Elizabeth Bonum, her heirs and assigns forever".

Mrs. Hewes appointed her son John Johnson and friend Capt. George Eskridge her executors. The witnesses of this will were Robert Bradley, Ralph Smithhurst and David Straughn. Mary Hewes! will is recorded in Will Book 1718-26 p. 175.

John Johnson died soon after his mother. His will was dated Oct. 1, 1720, and is recorded in Will Book 1718-26, p. 177.

This will was made before his mother's death and was not changed. His first bequest is "To my sister Mary Ball, land in Stafford Co., which my father-in-law (step-father) Richard Hewes gave me".

"To my mother Mary Hewes, the rest of my estate" --

Mother, Mary Hewes to be executrix.

The various wills make it plain that Mrs. Mary Johnson-Ball-Hewes was the mother of three children:

I John Johnson

II Elizabeth Johnson m. Samuel Bonum

III Mary Ball m. Augustine Washington

Elizabeth Johnson. It is apparent that Elizabeth Johnson had married Samuel Bonum before 1720 as her mother mentions her as Elizabeth Bonum.

It is the writer's opinion that Samuel Bonum lived in Cherry Point Neck on the boundary of Westmoreland Có., and owned land both in Northumberland and Westmoreland, and that he claimed both counties as his places of residence.

On March 20, 1723, Samuel Bonum was appointed overseer of the highways from Cox's Mill to the bottom of Coan Neck. (An abbreviation for Chicacone).

On Sept. 15, 1725, Peter Hack and Mr. Samuel Bonum were sworn Justices in Northumberland Co. This was an office equivalent to that of Judge of the Courts.

On Feb. 22, 1726, the will of Samuel Bonum was proved in Westmoreland County and gave "to my sister-in-law Mary Ball, my young dapple gray riding horse." This item is quoted from "The Mother of Washington and Her Times" by Mrs. Roger Pryor.

Elizabeth Johnson Bonum, the widow of Samuel Bonúm, half sister to Mary Ball, married probably about 1732, James Straugh, as on page 114 of Order Book 1729 to 37, "Elizabeth, wife of James Straughn", is mentioned.

In Order Book 1737-43, p. 76, the Court orders that James Straughn, guardian of Thomas Bonum, orphan of Samuel Bonum, should be possessed with the sd. orphan's part of the sd. Straughn's wife's part of the sd. Samuel Bonum's estate.

James Straughn died intestate soon after as on page 173 of this same Order Book, 1737-43, the Court granted Elizabeth Straughn letters of administration on the estate of James Straughn.

Evidently within a short time Elizabeth Johnson Bonum Straughn also died intestate and her sister-in-law, Winifred Straughn was by the court appointed guardian to Mary and Elizabeth Straugh, orphans of James Straughn, dec'd,, p. 246, Order Book 1737-43.

Upon the death of Winifred Straugh, her brother David Straughn was appointed her administrator.

It will be remembered that James Straughn was appointed guardian to his stepson Thomas Bonum, the orphan of Samuel Bonum.

On June 14, 1748, there was a settlement of accounts between Elizabeth Straughn (daughter of James and Elizabeth Straugh) and Wm. Hughlett, her former guardian, and Thomas Bonum (her half brother) is possessed with said Elizabeth's estate.

Thomas Bonum, the half-brother of Mary and Elizabeth Straughn married Saran, the widow of Lindsay Opie, prior to 1749.

In Order Book 1749-53, the Court ordered Thomas Bonum should make over the estate of Elizabeth Straughn to Samuel Blackwell and Adcock Hobson. This was probably to clear her estate before her marriage. She is mentioned as Elizabeth Straughn, orphan of James Straughn on July 13, 1752. She may have married before this date.

It seems probable that Elizabeth, the daughter of Elizabeth and James Straugh, and granddaughter of Mrs. Mary Johnson-Ball-Hewes, was born about 1735 or '36. This is, however, a guess based on other dates — Elizabeth Straughn was married before 1752 or '53 to Rodham Kenner Cralle, of Cherry Point Neck; whose father, John Cralle, and grandfather Capt. John Cralle, had been neighbors of Capt. Richard and Mrs. Mary Hewes.

On July 9, 1753, Rodham Kenner Cralle and Elizabeth, his wife brought suit against David Straughn (her uncle), no doubt for a part of Elizabeth's estate yet in his hands as administrator of Winifred Straughn, one of her former guardians.

The will of Rodham Cralle is dated May 13, 1759 and proved March 9, 1761.

He names his wife Elizabeth, his sons William Taite Cralle and Rodham Kenner Cralle and his daughter Mary Cralle. Mr. Wm. Eskridge was appointed his executor.

On Feb. 9, 1762, Elizabeth Cralle relinquished the legacies left her by the will of her deceased husband, Rodham Kenner Cralle. In other words, she elected to take her "thirds" given by law, in the land of her deceased husband.

On June 24, 1762, Elizabeth Cralle, widow, of St. Stephen's parish, gave a deed to Wm. Eskridge (executor of her dead husband Rodham Kenner Cralle) for 175 acres of land in aforesaid parish -- which descended to said Elizabeth Cralle and Mary Straughn, her sister, being daughters and co-heirs of James Straughn, the whole descended to sd. Elizabeth Cralle by the death of her sister Mary Straughn.

William Eskridge sold this tract in the following August as the next record shows:

Aug. 9, 1763. Wm. Eskridge and Betty his wife of St. Stephen's parish, deed to Thos. Jones of same parish for 175 acres of land -- which said land descended to Elizabeth Straughn and Mary Straughn as daughters and co-heirs of James Straughn, deceased, and by death of said Mary, the whole descended to said Elizabeth and said Elizabeth while she was the widow of Rodham Kenner Cralle, deceased, by deed bearing the date 24th. June, 1762, conveyed said tract to William Eskridge, first party to these presents.

It is evident that Elizabeth Straugh-Cralle married between June 24 and Aug. 9, 1763, George Harvey.

1763, Oct. 11. Wm. Eskridge and Betty, his wife, of St. Stephen's Parish, for the consideration of 100 acres — in aforesaid parish — doth sell and confirm unto Geo. Harvey of same parish, 200 acres in Cherry Point Neck (which sd. land was sold unto sd. Wm. Eskridge by said Geo. Harvey and Elizabeth, his wife, by deed bearing date Jan. 10, 1763 sd. land being the property of sd. Elizabeth by being daughter of Jas. Straughn). Wit. Sam'l Eskridge, Wm. Haynie, Eben Nelms.

On Oct. 11, 1763, George Harvey who intermarried with the widow of Rodham Kenner Cralle, deceased, petitioned the Court for possession of his wife's thirds of said deceased's estate.

On July 10, 1764, Elizabeth Harvey acknowledged a deed of gift to her two sons, Rodham Kenner and Wm. Taite Cralle, and she was appointed guardian to her stepdaughter Mary Cralle, orphan of Rodham Kenner Cralle, deceased. The deed is given herewith:

1764, July 10, Eliza beth Harvey of St. Stephen's parish deed of gift to Wm. Taite Cralle and Rodham Kenner Cralle (sons of sd. Elizabeth by her first husband Rodham Kenner Cralle) — for 190 acres of land — in Cherry Point Neck, St. Stephen's parish, which said land was made over by certain deeds from James Straughn and Elizabeth his wife unto John Lewis and John Cralle gent. and by said Lewis and Cralle reconveyed to the sd. Jas. Straughn and from sd. Jas. Straughn descended to Elizabeth party of these presents and by sd.

Elizabeth and George Harvey her late husband sold to Wm. Eskridge and by sd. Eskridge sold and reconveyed to sd. Geo. Harvey and by sd. Harvey's last will devised to sd. Elizabeth Harvey, party to these presents, etc., etc.

The will of George Harvey is dated Jan. 8, 1764, proved Feb. 13, 1764.

July 8, 1765, John Wroe brought suit against Elizabeth Middleton.

July 11, 1768, John Wroe is mentioned as the executor of George Harvey.

1768, June 26, Jerémiah Middleton and Elizabeth, his wife, deed to John Wroe, exc. of George Harvey, dec'd for all right, title or interest they or ever shall have to my part of sd. George Harvey's estate.

Nov. 11, 1766, Elizabeth Middleton brings suit against Jeremiah Middleton for ill usage.

1770, April 10, Rodham Kenner Cralle, orphan of Rodham Kenner Cralle, chose William Grayson his guardian.

Feb. 13, 1769, Lease from Jeremiah Middleton to Wm. Eskridge.

April 15, 1772, Wm. Eskridge made a settlement of the accounts of the estate of Rodham Kenner Cralle, deceased.

Elizabeth Straughn-Cralle-Harvey-Middleton was a widow again in 1776 as the following deed indicates:

This deed traces the descent of Elizabeth as will be seen from the wife of Richard Hewes (the wife named in his will as his executor, Mrs. Mary Hewes, the Grandmother of General Washington) thru! Elizabeth, daughter of Mrs. Mary Hewes, and mother of Elizabeth Middleton.

1776, Dec. 7 - Elizabeth Middleton, widow of St. Stephen's parish deed to Rodham Kenner Cralle, her son by her first husband of the same parish for 161 acres of land in Cherry Point Neck, St. Stephen's parish, which said land was granted by the Proprietors of the N. Neck, to Richard Hewes, May 1, 1700, and by will of the sd. Hewes devised to his wife (Mary Johnson Ball Hewes) during her life and after her death to her daughter (Elizabeth Johnson) which was mother to the said Elizabeth Middleton party to these presents and the said land was made over by certain deeds from James Straughn and Elizabeth, his wife, which was the father and mother of this present Elizabeth Middleton unto John Lewis and John Cralle gent. of this county and by the said Lewis

and Cralle reconveyed to the sd. James Straughn and from the said James descended to Elizabeth party of these presents and by the said Elizabeth and George Harvey, her second husband sold to William Eskridge and by the said Eskridge sold and reconveyed to the said George Harvey and by the said Harvey's last will devised to the said Elizabeth party to these presents and by the said Elizabeth given by a deed of gift to her sons Wm. Taite Cralle and Rodham Kenner Cralle, bearing date July 10, 1774, and the said William Taite Cralle dying not of age and before the said Elizabeth, mother to the said William Taite Cralle whom the said Elizabeth in deed to her two sons reserved her natural life in the said land. This Indenture Witnesseth that Cralle, his heir and assigns forever.

Signed etc., in the presence of:

George Barecroft Richard Hainey Mosely Mott.

Elizabeth Straughn-Cralle-Harvey-Middleton was married to Charles Haynie probably in 1777 and their daughter Sarah Ball Haynie was born Dec. 16, 1778. The St. Stephen's Parish record reads as follows:

1782, Oct. 14 -- Charles Haynie of Northumberland Co. (St. Stephen's parish) deed of lease to Rodham Kenner Cralle of Westmoreland Co., for a certain tract of land in St. Stephen's parish (Northumberland Co.) which sd. Haynie came into by his intermarriage with Elizabeth Middleton, the mother of the aforesaid Rodham Kenner Cralle, whose sd, right is good for and during the natural life of the sd. Elizabeth, the wife of the sd. Charles Haynie \*\*\* During the full term of the natural life of the sd. Charles Haynie, or the natural life of the sd. Elizabeth Haynie, at the decease of either, this lease is void.

Charles Haynie died intestate. The following abstract mentions his widow.

1786, Dec. 28 -- Mary Eskridge, widow of Samuel Eskridge and George Eskridge of St. Stephen's parish, planter and Nelly his wife, deed to Wm. Middleton of Westmoreland Co. for 150 acres in the aforesaid parish along the line of Presly Neale to a swamp dividing the land from the land now in posession of the widow or relict of Charles Haynie and Rodham Cralle, her son.

1788, April 15 -- Charles Clark and George Eskridge as his administrators of estate of Charles Haynie, dec'd, made settlement of the estate.

From the records cited, it is conclusively shown that Mrs. Mary Johnson-Ball-Hewes, was the mother of Elizabeth Johnson and Mary Ball, who were thus half sisters. That the

children of these half sisters were Elizabeth Straughn and George Washington, who were first cousins (of the half blood). That Sallie Ball Haynie, the daughter of Elizabeth Straughn (Mrs. Charles Haynie) was first cousin once removed, of General George Washington, our greatest American. Sallie B. Haynie was a near relative of General Washington.

Sept. 1, 1789, Elizabeth Haynie of the County of Freder-ick and State of Va. doth appoint Rodham Kenner Cralle of Frederick Co. her lawful atty. to transact all matters of settling or renting her land as he shall think proper.

Signed, Elizabeth Haynie. In the presence of Rawleigh Williams, James Brown and George A. Vanlandingham. Recorded Oct. 12, 1789.

It will be remembered that Frederick, Clark and London are the northmost counties of Virginia.

In "The Writings of George Washington", edited by Worthington O. Ford, Vol. 13, p. 41, there is a letter from General Washington to Robert Lewis (his factor or agent in Virginia). This letter is dated, Philadelphia, Feb. 22, 1796, and contains the following paragraph:

"Mrs. Haney should endeavor to do what she can for herself, -- this is a duty encumbent on every one; but you must not let her suffer, as she has thrown herself upon me; your advances on her account will be allowed always, at settlement; and I agree readily to furnish her with provisions, and for the good character you give her daughter, make the latter a present in my name of a handsome but not costly gown and other things which she may stand mostly in need of. You may charge me also with the worth of your tenement on which she is placed, and where perhaps it is better she should be, than at a great distance from your attentions to her".

Vol. 14, p. 287 is Washington's will in which he leaves "To Sally B. Haynie (a distant relative of mine) I give and bequeath three hundred dollars".

These extracts were made at my request by the Librarian of Congress, from the monumental work of Worthington C. Ford.

(Note by editor) Elizabeth Haynie, who died 29 April, 1796.

All records cited are from the court Records of North-umberland Co, Virginia except where otherwise stated.

Charles Haynie, the father of Sally B. Haynie was a direct descendant of Captain John Haynie who settled in North-umberland Co. in 1650.

"These records establishing the relationship of George Washington with Sarah Ball Haynie were briefed and compiled by Mrs. O. A. Keach Wichita, Kansas".

## THE LINEAGE OF SARAH BALL HAYNIE.

Nicholas Morris (1), Captain John Haynie (2), Captain Richard Haynie (3), Ormsby Haynie (4), Charles Haynie (5), Sarah Ball Haynie (6).

This lineage covers the time from 1605, the birth of Nicholas Morris to the birth of Sarah Ball Haynie in 1778.

This is an extremely interesting family record and there are few Virginia genealogies that are more complete than this.

The male and female lines are quite definitely established by the Northumberland County records, except in the case of Martha, wife of Nicholas Morris, as follows:

- 1 Nicholas Morris m. Martha.
- 2 Captain John Haynie, m. Jane Morris.
- 3 Captain Richard Haynie m. Elizabeth Bridgar.
- 4 Ormsby Haynie m. Sarah Dawson.
- 5 Charles Haynie m. Elizabeth Straughn.

Charles Haynie and Elizabeth Straughn (Cralle Harvey Middleton) were married probably in 1777.

6 - Their daughter, Sarah Ball Haynie was born Dec. 17, 1778. The St. Stepeh's Parish record reads, as follows: Sarah Ball Haynie, daughter to Charles and Elizabeth was born Dec. 16, 1778.

Nicholas Morris was a Justice of Northumberland as early as 1652.

He was born in 1605 as a deposition made Nov. 21, 1653 gives his age as 48 years. His wife, Martha Morris, stated in September, 1665 that she was 46 years of age.

The name of Nicholas Morris appears many times in the early records of the county and he is shown to be one of the able men of the community.

Nicholas and Martha Morris had two children, Anthony and Jane. On Nov. 20, 1658, George Colelough who married Ursula, the widow of Col. John Mattrom delivered from the Mattrom estate, "unto Nicholas Morris 1 mare for the sole use and benefit of Jane Haynie, daughter of sd. Morris and now wife of John Haynie".

The will of Mr. Nicholas Morris was dated Nov. 21, 1560 and proved Jan. 20, 1664. He mentions his wife Martha, his son Anthony, his daughter Jane Haynie, and his grandchildren Martha, Elizabeth and Richard Haynie.

John Haynie first appears in the Northumberland County Records, in 1649-50. He was born in 1624, as a deposition made Aug. 20, 1655 gives his age as 31 or thereabouts. He served in public life almost continuously for more than forty years.

In 1654 the Court ordered "that Mr. John Haynie shall be Clarke of the Markett for Great Wicocomoco & Little Wicocomoco". This was a County market established by the Virginia Assembly for the exchange of commodities between the settlers and Indians.

The first record of the establishment of churches in Northumberland County is Aug. 22, 1655. The church wardens for the Wicomico congregation were Maj. Samuel Smyth, Mr. John Haynie, Mr. James Hawley, Edward Coles and Richard Shaw.

John Haynie brought into the Virginia Colony about fifty persons, and the Land Records at Richmond show that he patented large grants of lands for headrights. He first settled in Wicomico parish in the lower part of Northumberland County but afterwards moved to Fairfields in the upper part of the county. He was a Burgess from Northumberland Co. in 1657-58.

-- Standards Colonial Records and Northumberland Co. Court Records.

On Nov. 21, 1659 a bill of George Abbott against him was considered null and void. "John Haynie being a Burgess". June 6, 1661, John Haynie was sworn a surveyor by order of the Governor.

Sept. 8, 1668. John Haynie was appointed King's Attorney in behalf of the county.

May 20, 1671, Jane Haynie acknowledges sale of land made by her husband John Haynie.

Dec. 8, 1677. In an account of the charges to Northumberland Co. for the Susquehanna war of Sept. 1675, payment was ordered to Captain Haynie, commander of the expedition, to Thos. Brereton, John Graham, Lieut., Dennis Carty, Ensigne, John Hudnall and Mr. Galland, Sergeants, and Mr. Philip Shapleigh.

On Jan. 15, 1678, a difference between John Kirk and Mr. Philip Shapleigh to be decided by Captain John Haynie and Philip Shapleigh.

From this time on the records designate him as Captain John Haynie.

On March 15, 1631-82, at a court held for Northumberland Co., Capt. John Haynie is included in a list of Gentlemen Justices. He was a Justice for many years. This was an office of great dignity and only those of the best social standing were appointed to the office.

Jan. 19, 1694, Captain John Haynie (Now about 70 years old) entered Mr. Richard Haynie his attorney in all cases.

Captain Haynie died in 1697. On July 22, 1697, "The last will and testament of John Haynie Sr. was proved by the oaths of Richard Robinson and John Haynie, Jr. witnesses thereto and the said will is recorded". Captain Haynie's will was burned in the fire of 1710, but other court records prove the names of his children: Martha, Elizabeth and Richard were mentioned in the will of their grandfather, Nicholas Morris. There were also Anthony, John and probably Ann.

Richard Haynie, eldest son of Captain John and Jane (Morris-Haynie) was born probably before 1659. He was married to Elizabeth Bridgar October 10, 1681. The following inscription on an old tombstone in the Haynie burying ground, was made for me by Doctor G. W. Beale about ten years ago.

"Here lyeth the body of Elizabeth Haynie, daughter of Richard and Jane Bridgar. Was born July 16, 1665, married to Richard Haynie October 10, 1681, by whom she had 8 children and died his wife April 2, 1697."

Richard Haynie followed his father's profession and became an attorney. The first mention of him in a business way is March 15, 1681/2 when he was attorney for Wm. Templar. June 18, 1691, Mr. Richard Haynie and Mr. Charles Harris were sworn to the oaths lately imposed by Act of Parliament.

August 18, 1691, Richard Haynie is mentioned as one of the Justices of Northumberland Co. He was Captain of County Militia and a Burgess from Northumberland Co., for 1695, 1696, 1698, 1702, 1703, 1704 and 1705.

July 19, 1706, Captain Richard Haynie was sworn "High Sheriffe", "pursuant to her Majesty's commission."

Sept. 22, 1709 sued by Robert Carter, Eqr. of Lancaster Co. for Proprietors of Northern Neck for 300 pds Sterling."

May 7, 1710 Captain Richard Haynie appointed one of the "Gentlemen Justices".

Captain Richard married sécond Elinor (probably)
Mottrom about 1700. March 15, 1725, the last will and
Testament of Captain Richard Haynie dec'd was brought into
Court by Mrs. Elinor Haynie (his widow) and proved by
the oaths of Henry Christopher and Thomas Bayles.
Richard Haynie's will:

In the name of God Amen I Richard Haynie being very sick and weak of body but of sense and memory blessed to God for the same do here make my last will and testament first I bequeath my soul to Almighty God my Creator and my body to be decently buried at the discretion of My Exor. hereafter mentioned. Item I give and bequeath to my son Bridgar Haynie all the land that belongs to me on the right hand of the road as you go down from the Courthouse downward to him and the lawful heirs begotten of his body otherwise to fall to Bridgar Haynie and his heirs forever. Item I give to my son Richard Haynie all my plantation whereon I now live with the land belonging to it as far as ye first branch at the Tan Troug's to him and the heirs lawfully begotten of his body and in case the said Richard die without lawful issue of his body then the land to fall to Macksamilion Haynie and Ormsby Haynie to the lawful heirs of their body. Item I give and bequeath to my sons Ormsby Haynie and Charles Haynie all my land from the aforesd. branch to the extent of my land to them and to the heirs lawfully begotten of their body. Item I give and bequeath to my son Samuel Haynie a piece of land joining to Richard Oldham to him and his heirs forever of Dividend to be equally divided between my four daughters Katherine Haynie, Elinor Haynie, Winifred Haynie and Anna Haynie to them and their heirs forever. Item I give and bequeath to my two daughters Winifred and Anna Haynie my two negroes George and Beck after my wife Decease. Item it is my will that my estate may not be brought to appraisement. Item I give and bequeath to my daughter "lizabeth Smith a gold ring of Twenty Shillings price. Item this my will that my loving wife Elinor Haynie with the assistance of Major George Eskridge to be my Exors. of this my last will and testament and hereunto I do revoke all other wills and testaments from the

beginning of the world until this day as witness my hand and seale this 3rd. day of October in the year of our Lord 1724.

Signed, sealed in the presence of usHenry Christopher. Richard Haynie. (Seale)
Thomas Baylis.

The children of Captain Richard and Elizabeth Bridgar Haynie:

These names were taken from St. Stephen's Parish Register, which has many names missing, - from court records, and from Captain Richard Haynie's will. They may not be in order of age but it is thought that they are approximately correct.

Captain John Haynie (1) Captain Richard (2) Ormsby (3)

Ormsby Haynie, son of Captain Richard and Elizabeth Bridgar Haynie, was born probably about 1690.

He married Sarah Dawson Neale, widow of Matthew Neale, about 1727.

Ormsby Haynie's name appears very frequently in the court records and from the many accounts owing him, he must have been a merchant.

March 17, 1736, Ormsby Haynie, James Farned and Gilbert Harold were appointed processioners and ordered by the court to procession the fourth precinct of St. Stephen's Parish.

June 9, 1740 he was appointed constable.

August 12, 1740 appointed overseer of the highways in the name of Rodham Kenner.

Feb. 13, 1741. Appraisers met at house of Mr. Ormsby Haynie dec'd. Among other household goods were seven silver spoons valued at 21 - 14s. 10d. A parcel of books 12 - 5s.

Letters of administration on the estate of Ormsby Haynie granted to his widow Sarah Haynie.

1744, March 12. Matthew and John Neale chose Sarah Haynie (their mother) their guardian.

1749. The will of Sarah Haynie presented to the court by Matthew Neale, executor.

Will of Sarah Haynie, dated Dec. 1, 1748, proved April 10, 1749.

To my sons Matthew and John Neale, sons Richard, George, Charles and Wm. Haynie, daus. Sarah & Elizabeth. Son Chasat 16 to be bound to a trade having the liberty to choose his own master. Son Wm. at 16 to be bound to a good trade with liberty to choose his own master. Mathew Neale, Exec.

1742-3 Mar. 14 This Indenture Witnesseth that John Neale, son of Matthew Neale, by and with the consent of Ormsby Haynie and Sarah his wife mother of the sd. John Neale doth put himself apprentice to Francis Brown Joyner to learn his art & with him after the manner of an apprentice to serve from the Day of the date hereof for and during the term of five years next ensueing during all which term sd apprentice his sd master faithfully shall serve his secrets keep his lawfull commands everywhere gladly do he shall do no damage to his sd master see it done by others he shall not wast his sd masters goods nor lend them unlawful mony. during the sd term he shall not play at cards Dice or any other unlawful game whereby his sd master may be damaged with his just own goods nor the goods of others he shall not absent himself day or night from his sd masters service unlawful nor haunt ordinarys, but in all things behave himself as a faithful apprentice in the trade he now followeth and the sd Francis in consideration of the premises doth promist & contract by these presents to teach his sd apprentice the art or mistery of a joiner & chairmaker & farther shall procure & provide for him sufficient meat drink apparel lodging washing and all other necessarys during the sd term & for the true performance of all and every of the sd covenents & agreements either of the sd partys bindeth himself unto the other firmly by these presents. In witness whereof they have interchangably put there hands & seals hereunto this 14th Day of March in the 16th year of the Reign of our Sovereign Lord George the Second King of Great Britan France & Ireland Anno Domi. 1742-3. Signed and sealed in presence John Neale of the court.

1742-3 Mar. 14 This Indenture from John Neale to Francis Brown was acknowledged signed sealed and delivered in North Co. court by the sd. Neale unto the sd. Brown in presents & by consent of Ormsby Haynie his guardian & on the motion of sd Brown admitted to Record p. 227.

Dawson's Mill re-appears in the records in the following sale--1751 Sept. 24. John Neale sold Dawson's grist mill to brother Matthew Neale given him by his mother Sarah Haynie, one of the coheirs of her father John Dawson and grandfather Henry Dawson.

Feb. 13, 1740. George Haynie, 17 yrs. old next March, bound to Wm. Eskridge till he attain the age of 21. Wm. Eskridge to learn his the trade of a joiner. Samuel Eskridge and John Foushee gave security with Wm. Eskridge for 5000 pds to bond for performance.

1752, Feb. 9, Wm. Haynie, son of Sarah Haynie by strict directions of sd. Sarah Haynie as well as by his own free will and by approbation of Matthew Neale (half brother) binds himself apprentice to Geo. Haynie to learn trade of joiner until 21, being 16, Nov. 12, 1755.

1776, May 13. Deed from Go. Haynie and Katherine, his wife, to Winnifred Berry.

Matthew Neale eldest son of Sarah (Dawson Neale) Haynie m. Mary Harding dau. of Wm. and Sarah Ball Harding, Gd dau of Capt. Joseph & Mary Mottrom Ball. (On Aug. 13, 1772, Matthew Neale was com. Capt. of Militia).

1765. May 13. Mathew Neale and George Haynie give special security for Chas. Haynie.

1756. June 11. Matthew Neale and Mary his wife of St. Stepehen's parish deed to Wm. Eskridge for a water grist mill in aforesd. parish called Dawson's mill ——\frac{1}{2} descended to Matthew Neale as heir to his father Matthew Neale, who purchased the other half from John Foushee, gent. and Elizabeth his wife, Dec. 19, 1722 \*\* the other half was purchased from John Neale Sept. 4, 1751, which half was devised to John Neale by will of Sarah Haynie who was heiress to same as one of the daus. & coheirs of John Dawson.

1763 - Mach. 14. Samuel Eskridge and Mary his wife deed of gift to Vm. Lewis, son of sd. Mary for tract of land called the Ordinary Plantation \*\* except that small piece which Mrs. Haney (Sarah Dawson Haynie) made over and acknowledged \*\* unto John Foushee, Gent., Samil Eskridge & Mary his wife.

1763 May 7. Wm. Eskridge & Betty, his wife of St. Stephen's Parish, deed to Thos. Villiams of the same parish for a water grist mill \*\* called Dawson's Mill\*\*

(Betty Eskridge was a daughter of Jas. Farned.)

On July 16, 1785, Peter Cox, Abraham Beacham and Chas. Haynie were witnesses to a deed.

1786, Dec. 28. Mary Eskridge, widow of Sam'l Eskridge, dec'd and George Eskridge of St. Stephen's par. planter and Nelly his wife, deed to Vm. Middleton of Westmoreland Co. for 150

acres \*\* purchased by Sam'l Eskridge, father of sd George \*\* along the line sd. Neale to a swamp dividing sd land from the land now in possession of the widow or relict of Charles Haynie & Rodham Cralle, her son.

1788 Feb. 11. Inventory of the estate of Chas. Haynie.

1788 April 15. Settlement of Chas. Clarke and George Eskridge's administration of the estate of Charles Haynie, dec'd.

### NOTES ON THE STRAUGHN FAMILY.

David Straughn is mentioned in the Northumberland County records as early as 1700. He lived in St. Stephen's Parish and in Cherry Point Neck. In Mrs. Roger Pryor's book, "The Mother of Washington and Her Times," it is said that he was a schoolmaster. My opinion is that he was a well-born young Scotchman who emigrated to Virginia a short time prior to 1700.

The Order Book 1699-1713, p. 9, states that Mr. David Straughn married the executrix of Villiam Parker. On page 15 of the same book it is stated that Jane, the wife of Vm. Parker, was the daughter of Richard Pearse (this name may be Percy) Elizabeth Parker daughter of Vm. Parker, and that David Straughn married Ruth, executrix of Vm. Parker.

Order Book 1678-1698, p. 354, Wm. and Ruth Parker, suit against Wm. and Susanna Webb.

Jane may have been the first wife and Ruth second wife of William Parker. Anyway David Straughn married Ruth, the executrix of Wm. Parker, probably about 1701.

That David Straughn was of good birth and social stand-ings the following record is proof:

1703, Sept. 15. Richard Booth deed to David Straughn, Gentleman for tract of land situated in Mattapony Neck containing 100 acres. On the same date Philip Bussle and Jane, his wife, deed to David Straughn \*\*\* for 75 a. situated in Mattapony. It will be remembered that David Straughn was one of the witnesses to the will of Mary Hows.

The will of John Opie, dated Feb. 13, 1722, names Mr. Griffin Fautleroy, Samuel Bonum and David Straughn, his trustees.

The will of Ann Opie, widow of John, dated Dec. 31, 1724, mentions Mrs. Straughn.

The will of Richard Kenner, dated Feb. 1725, mentions his godson Richard Straughn, and was probated by Mr. David Straughn.

The will of Francis Kenner, dated April 21, 1725, mentions his godson David Straughn.

On April 17, 1728, Mr. John Cralle, the surviving executor of Capt. John Cralle, presented the will to Capt. Cralle, making oath that there was only one surviving evidence, Mr. David Straughn, who is not able to come to court.

David Straughn probably died before 1730 and I have no record of his will.

His son, James Straughn, born 1702 is mentioned as the appraiser of an estate Jan. 17, 1728. He probably married Elizabeth Johnson Bonum, widow of Samuel Bonum about 1730, or a year or two afterwards. This statement is presumptive merely as no record confirms it. James Straughn had either married before or Elizabeth Bonum had married — Toby after the death of Samuel Bonum, before she married James Straughn, as there is a record in Order Book 1737-43 after the deaths of both Elizabeth and James Straughn, that mentions Elizabeth Tob v, former wife of James Straugh, deceased.

But I am giving Elizabeth Bonum-Straughn the benefit of the doubt.

It will be remembered that James Straughn died intestate and his wife Elizabeth was admitted his administratrix. Elizabeth died shortly thereafter, and Winifred Straughn, the sister of James, was a prointed guardian to his two young daughters, Mary and Elizabeth. Some time after 1743 Winifred Straughn also died and her brother David was admitted administrator of her estate.

The children of James and Elizabeth Straughn were:

I Mary, died unmarried.

II Elizabeth, married Rodham Kenner Cralle and had William Tate Cralle, died unmarried. and Rodham Kenner Cralle, married Katherine (and had Rodham). (Hayden's Virginia Genealogies).

Elizabeth Straughn Cralle, by her last marriage with Chas. Haynie, had Sarah Ball Haynie, born Dec. 16, 1778, fourth in descent from David Straughn; the immigrant. Sarah Ball Haynie (4), Elizabeth Haynie (3), James Straughn (2), David Straughn (1).

Sarah Ball Haynie was also fourth in descent from Mrs. Mary Johnson. Sarah Ball Haynie (4), Elizabeth Straughn Haynie (3), Elizabeth Johnson (2), Mary Johnson (1). The Straughns have been socially of the best from the time of Mr. David Straughn, gent., the immigrant, to the present day.

Mrs. Charles Haynie, as is shown, was the granddaughter of Mrs. Mary Johnson-Ball-Hewes.

Sarah Ball Haynie married Thomas Blackburn March 20, 1800.
