COL. JOHN CHEW, of Somersetshire, England, *b.* 1590, *d.* 1655, immigrated to Virginia in the "Charitie," 1620. His wife, Sarah, same later in the "Sea Flower." In 1625-9 he was a member of the House of Burgesses from Hog Island, and in 1642-4 from York Co., Va. His son, Samuel, moved to Maryland and settled in Calvert Co. From 1668 to 1677 Samuel CHEW served as Judge of the High Court of Chancery. William CHEW, son of Samuel, *m.* at the house of William RICHARDSON, 20th Dec. 1690, Sidney WYNNE, dau. of Dr. Thomas WYNNE.

DR. THOMAS WYNNE, of Bron-Vadog, near Caerwys, *b.* 1630, came to America in the ship "Welcome" with William PENN, in 1682. Was the first physician in Pennsylvania, and Speaker of the First House of Assembly for the province of Pennsylvania. He and his wife died in Sussex Co., Del. Dr. WYNNE was a direct lineal descendant through twenty-one generations from Rhys AP TUDOR, Prince of South Wales. (Pedigree CLVII, "Americans of Royal Descent," by BROWNING.)

PHILIP THOMAS, *b.* 1620, in Bristol, England; *d.* in Anne Arundel Co., Md., July, 1675; emigrated to Maryland in 1650 with his wife, Sarah HARRISON. Before 1655 he was commissioned Lieutenant of the provincial forces. In 1656 he was a member of the High Commission to govern the colony under Lord Protector CROMWELL. 22d Mar. 1657-58, he was one of the commissioners to surrender the government to Lord Baltimore. He was a direct lineal descendant, fifth generation, of Lady Catherine HOWARD, who *m.* Rice AP GRIFFITH, of Carew (1508-31). Lady Catherine HOWARD was a direct lineal descendant of Edward I, of England (1239-1307).

SAMUEL THOMAS, *b.* 1655, *d.* 1740, son of Philip, *m.* 1688, Mary HUTCHINS. Sarah THOMAS, *b.* 1689, *d.* 1724, dau. of Samuel, *m.* 1705, Joseph RICHARDSON. Sarah RICHARDSON, *b.* 1719, dau. of Joseph, *m.* 1737, Francis PIERPONT. Mary PIERPONT, dau. of Francis, *m.* 1762, Richard RICHARDSON, Jr. Sarah RICHARDSON, dau. of Richard, Jr., *m.* 1799, Bayles COOMBS. Rebecca Davis COOMBS, *b.* 9th Oct. 1804, *d.* 15th Dec. 1873, dau. of Bayles, *m.* 9th Dec. 1823, Nicholas BOOGHER III, of Frederick Co., Md.
