This information is taken from the book "Marylanders to Kentucky, 1775-1825" by Henry C. Peden Jr. I have no further information on this family, but am posting it in response to queries about them on this list. I hope there is some new information for somebody.

WIGHT, WHITE. John Wight (white) died in Prince George's County, Maryland in 1729. His wife was Anne GREENFIELD. They were the parents of Isle of WIGHT whose sons settled in the Bluegrass Region of Kentucky. Isle of Wight, Jr. Settled north of Bardstown in Nelson County and died in 1816. His brother William Wight (White) married Rebecca Blanford in Prince George's County, Maryland in 1783 and settled in Washington County, Kentucky and died there in 1823. Their father was the Isle of Wight named as a son of John Wight who died in Prince George's County in 1729. William White's sons were: John B. Wight, who married Christina Elder, a daughter of Thomas Elder and Elizabeth Spalding of the Fairfield, Kentucky area; Thomas Noble Wight, who married Harriet Lily and settled in Breckinridge County, Kentucky; and Richard Snowden Wight (White), who married Mary Worland and lived in Springfield, Kentucky. Item: I will and desire that Henry Thomas Mudd, shall sell and convey all my right and title to a parcel of land called New Bradford, containing 100 acres and the money to be laid out in land for the use of my son Ignatius H. Mudd. Item: I will and desire that Henry Thomas Mudd my Executor hereafter appointed shall convey unto Levin Sothoron 100 acres of land called Gates Range if he pays up the principal and interest according to contract.

Indenture made April 7, 1774; between Thomas Burnes, Mary Burnes his wife and Moses Orme of the one part and Thomas Gantt, Jr. of the other part. Whereas Mary Throne by her last will and testament did devise to her daughter Mary Throne now wife to Thomas Burnes part of a tract called "Taylorton" containing about 70 acres and whereas the said will does not direct what part of a tract the land shall be laid off to her daughter and whereas Moses Orme intermarried with Virlinder Taylor daughter of Samuel Taylor and has since the decease of Mary Throne purchased from the coheirs of Samuel Taylor all their right and estate to the aforesaid tract called "Taylorton" and Moses Orme being desirous that Mary Throne's will should be complying with and likewise thinking it was the intention of the divisor that the said 70 acres should be laid off to her daughter out of that part of the land which was purchased from Samuel Taylor by John Wight, grandfather to

the divisor aforesaid for which reason he the said Moses Orme has made himself a party in this deed with Thomas Burnes and Mary Burnes his wife that the right and title to the above 70 acres of land may be the better secured. Wherefore the said Thomas Burnes, Mary Burnes his wife and Moses Orme in consideration of 109 pounds 4 shillings sterling money of Great Britain paid by Thomas Gantt, Jr. has sold by these presents the aforesaid tract called "Taylorton" containing 70 acres and beginning at a bounded white oak standing near the mouth of Taylor's Branch and bounded on the 7th line of that part of the tract called "Taylorton" which was bought by Thomas Gantt from Samuel Taylor and uxor. Signed Thomas Burnes, Mary Burnes, Moses Orme in the presence of and acknowledged before John Harrison, Alexander Howard Magruder and at the same time Mary Burnes wife of Thomas Burnes relinquished her right of dower
